**Dr. Ari Ackerman** is a lecturer and Golinkin Professor of TALI Jewish Education at the Schechter Institute of Jewish Studies in Jerusalem, where he teaches courses in the areas of Jewish philosophy and education. He received his Ph.D. in Jewish Thought from Hebrew University. His most recent publication was a critical edition of the sermons of Zerahia Halevi Saledin (Beer Sheva University Press, 2013), and he is currently working on a monograph on creation and codification in the philosophy of Hasdai Crescas.

**Dr. Nadav S. Berman** is a scholar of Jewish thought interested in its connections with classical American pragmatism. In this context, Nadav's doctoral dissertation (Hebrew University, 2018) investigated three 20th century Jewish thinkers, including Mordecai M. Kaplan. Nadav was a postdoctoral associate at Yale University, and is currently a fellow at the Center for Jewish Studies at Harvard University and adjunct lecturer at The Jewish Theological Seminary.

**Daniel G. Cedarbaum** is the co-founder and Executive Director of The Mordecai M. Kaplan Center for Jewish Peoplehood. From 2002- 2006, he was the President of the Jewish Reconstructionist Federation, and a member of the Conference of Presidents of Major American Jewish Organizations. In addition, he has served as a member of the Board of Governors of the Reconstructionist Rabbinical College and as a member of the Executive Committee and the Board of Trustees of the United Jewish Communities (now The Jewish Federations of North America). He is the author of several articles on various aspects of Kaplan's thought and the Reconstructionist movement. He is a graduate of Harvard College and Harvard Law School.

**Dr. Emily Filler** is currently Assistant Professor in the Study of Judaism at Washington and Lee University, having previously taught at Earlham College. She received her Ph.D. in the Study of Judaism from the University of Virginia, her Master of Theological Studies degree from the Harvard Divinity School, and her B.A. from The George Washington University. Her research is in the relationship between Judaism, philosophy, and classical Jewish texts; she is completing her first book, Modern Judaism and Biblical Violence. She is co-editor of *The Journal of Jewish Ethics* and serves on the board of the Society of Jewish Ethics.

**Dr. Sanford Goldberg** is the Chester D. Tripp Professor in the Humanities and Professor of Philosophy at Northwestern University, where he has taught since 2007. His research focuses on the nature and social dimensions of mind, language, and knowledge. He received his Ph.D, in Columbia University, 1995; BA, Rutgers University, 1989) He is the author most recently of *Collected Essays in Social Epistemology* (Oxford University Press, forthcoming), *Conversational Pressure* (Oxford University Press, 2020) and *To the Best of Our Knowledge* (Oxford University Press, 2018). He has served as President of Beth Hillel Bnai Emunah synagogue in Wilmette, IL (2018-20) and Chair of the Board of Fiedler Hillel at Northwestern University (2016-18).

**Dr. Arthur Green** is Irving Brudnick Professor of Jewish Philosophy and Religion at Hebrew College, and the founding dean and current rector of its Rabbinical School. He is Professor Emeritus at Brandeis University, where he occupied the distinguished Philip W. Lown Professorship of Jewish Thought. He was educated at Brandeis University and received rabbinic ordination from the Jewish Theological Seminary of America. Dr. Green previously taught at the Reconstructionist Rabbinical College, where he also served as Dean and President, and the University of Pennsylvania. A founder of the *chavurah* movement in American Jewish life, Dr.

Green is a scholar of Jewish history and a theologian who seeks to develop a contemporary Jewish mysticism based on the Hasidic model. His translations and interpretations of Hasidic teachings include the two-volume *Speaking Torah: Spiritual Teachings from Around the Maggid's Table* (2013). He is the author of works including *Tormented Master: A Life of Rabbi Nahman of Bratslav; Keter: The Crown of God in Early Jewish Mysticism;* and *Radical Judaism: Re-thinking God and Tradition*. His two-volume A New Hasidism, co-edited with Dr. Ariel Mayse, appeared in 2019. Judaism for the World: Reflections on God, Life, and Love will be published in 2020 by Yale University Press.

**Bar Guzi** is a doctoral candidate in the Near Eastern and Judaic Studies Department at Brandeis University and a visiting instructor in religion at Wesleyan University. He is completing his dissertation on Jewish naturalistic theism in twentieth-century American Jewish thought, focusing on the work of Mordecai Kaplan, Hans Jonas, and Arthur Green. He holds a B.A. in Philosophy and Jewish Philosophy and a high school teaching diploma in Jewish Thought, both from Tel Aviv University.

**Dr. Michael S. Hogue** is Professor of Theology, Ethics and Philosophy of Religion at Meadville Lombard Theological School in Chicago. He received his Ph.D. in Theological Ethics from the Divinity School at the University of Chicago (2005). He is past editor of the American Journal of Theology and Philosophy; Co-Director of the Religion, Vulnerability, and Resilience Project (currently funded by Arthur Vining Davis Foundation); and a Vice President of the Institute for American Religious and Philosophical Thought. He is the author of numerous articles and three books, the most recent of which is *American Immanence: Democracy for an Uncertain World* (Columbia, 2018).

**Dr. William Plevan** holds rabbinic ordination from the Jewish Theological Seminary and a Ph.D. in Religion from Princeton University, where he wrote a dissertation on the philosophical anthropology of Martin Buber. He has taught Jewish philosophy, theology and ethics at the Jewish Theological Seminary and Gratz College. His article "Holiness in Hermann Cohen, Franz Rosenzweig, and Martin Buber," was recently published in *Holiness in Jewish Thought*, edited by Alan Mittleman (Oxford University Press, 2018). Dr. Plevan is also the author of "Martin Buber: The Dialogue With God," in *Jewish Theology in Our Time* (Jewish Lights Publishing, 2010) and was the editor of the festschrift *Personal Theology: Essays in Honor of Neil Gillman* (Academic Studies Press 2013).

Rabbi Dr. Rachel Sabath Beit-Halachmi is a well-known thought leader, institutional builder, strategic innovator, published author, and pubic speaker. Ordained at HUC in New York in 1995, Rabbi Sabath also earned a Ph.D. in Jewish Philosophy from the Jewish Theological Seminary. She is completing two books for publication and currently serves as a Senior Fellow of The Mordecai M. Kaplan Center for Jewish Peoplehood and as the Director of Content for the recently launched international project Our Common Destiny. Most recently, Rabbi Sabath was the National Director of Recruitment and Admissions, Assistant Professor of Jewish Thought and Ethics, and President's Scholar at the Hebrew Union College-Jewish Institute of Religion (HUC). Previously Rabbi Sabath served as Vice President of the Shalom Hartman Institute in Jerusalem and for over a decade as a member of the Institute's faculty. Rabbi Sabath is co-author of the popular Jewish guide entitled *Preparing Your Heart for the High Holy Days* as well as a guide to

ethical practice, entitled Striving Toward Virtue. She serves on the editorial board of the *CCAR Journal: The Reform Jewish Quarterly* and as a consulting editor for the multi-denominational journal *Zeramim: An Online Journal of Applied Jewish Thought*.

**Dr. Mel Scult** is Professor Emeritus of Judaic Studies at Brooklyn College, City University of New York, and a member of the history faculty at the C.U.N.Y. Graduate School. He is the author of *Judaism Faces the Twentieth Century: A Biography of Mordecai M. Kaplan* and editor of *Communings of the Spirit-the Journals of Mordecai M. Kaplan 1913-1951* (third volume to appear in October 2020). His article on Solomon Schechter, "Schechter's Seminary," appeared in *Tradition Renewed A History of the Jewish Theological Seminary* edited by Jack Wertheimer. He has lectured widely at universities including Stanford University, Mc Gill University, Brandeis University, Georgetown University, and the Van Leer Institute in Jerusalem. He is a Vice President of The Mordecai M. Kaplan Center for Jewish Peoplehood.

Rabbi Gordon Tucker is Senior Rabbi Emeritus at Temple Israel Center in White Plains, NY, where he served as Senior Rabbi from 1994 to 2018. Currently, he is a Senior Fellow at the Shalom Hartman Institute of North America. Rabbi Tucker holds the A.B. degree from Harvard College, a Ph.D. in Philosophy from Princeton University, and Rabbinic Ordination from The Jewish Theological Seminary of America (JTSA). He was Assistant Professor of Jewish Thought at JTSA from 1979 to 1994 and Dean of the Rabbinical School from 1984 to 1992, where he oversaw the training of hundreds of rabbis. He was a member of the Rabbinical Assembly Committee on Jewish Law and Standards from 1982 to 2007. In 1979-80, he was a White House Fellow, and served as Special Assistant and chief speechwriter to U.S. Attorney General Benjamin R. Civiletti. He is a prolific author whose works include articles on Jewish theology and law and *Heavenly Torah*, a translation of and commentary on Abraham Joshua Heschel's three-volume work on Rabbinic Theology. An anthology of Rabbi Tucker's writings, *Torah for its Intended Purpose*, was published in 2014, and his commentary on Pirkei Avot was published by The Rabbinical Assembly in 2018.

Rabbi Kari Hofmaister Tuling received rabbinic ordination in 2004 and earned her PhD in Jewish Thought in 2013, both from the Hebrew Union College-Jewish Institute of Religion in Cincinnati. She has served congregations in Connecticut, Indiana, New York, and Ohio, and has taught Jewish Studies courses at the University of Cincinnati and the State University of New York, Plattsburgh. She currently serves as the rabbi of Congregation Kol Haverim in Glastonbury, Connecticut. Recent publications include chapters in *Inscribed: Encounters with the Ten Commandments* (2020) and *A Life of Meaning: Reform Judaism's Sacred Path* (2018), both by the CCAR Press. Her first book, *Thinking About God: Jewish Views*, has just been published by the Jewish Publication Society/University of Nebraska Press.

**Dr. Ellen M. Umansky** is the Carl and Dorothy Bennett Professor of Judaic Studies and Founding Director of the Bennett Center for Judaic Studies at Fairfield University in Fairfield, CT. She was previously a tenured Associate Professor of Religion at Emory University in Atlanta, visiting Professor of Religion at Haverford College, and visiting Lecturer at Hebrew Union College-Jewish Institute of Religion in New York. She received her B.A. in Philosophy from Wellesley College, her Master of Arts in Religion from Yale University, and her Ph.D. in Religion from Columbia University. The author of several books and almost one hundred essays and book chapters on

Liberal Judaism and Jewish feminist theology, she is currently working on a book on constructive Jewish feminist theology under contract with New York University Press.

**Dr. Howard Wettstein** is Professor of Philosophy at the University of California, Riverside. He received his B.A. from Yeshiva College and his Ph.D. in Philosophy from The City University of New York. He previously taught at the University of Minnesota (Morris) and the University of Notre Dame. He has also held visiting positions at Stanford University and the University of Iowa. He has published two books in the philosophy of language and, most recently, *The Significance of Religious Experience* (Oxford University Press, 2014), a defense of a naturalistic understanding of traditional Judaism. He is at work on a new book, *The Fabric of Faith*. He is Senior Editor of *Midwest Studies in Philosophy*.
